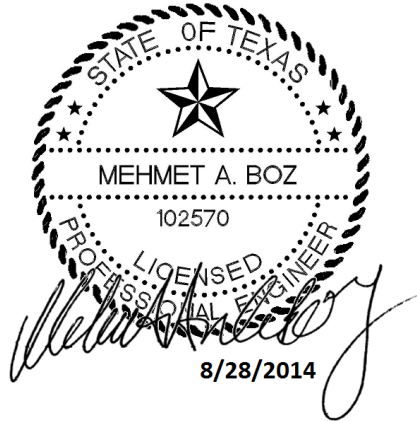

## CONTRACTOR QUESTIONS AND CLARIFICATIONS FROM MANDATORY PRE-BID MEETING

1. Question: Will there be a single Right-of-Way permit for the entire contract or will individual permits be required for each work order?  
**Response: The Contractor shall coordinate Right-of-Way permit related issues with the City of San Antonio. The contractor shall be responsible for all costs associated with registering with the City of San Antonio Right of Way Office (COSA ROW), applying and obtaining COSA ROW Street cut permit(s) as required for the project and shall keep the permit active during the course of the work. Contractor is also responsible for the initial permit, permit renewals, expedited permits and any and all costs inclusive of but not limited to COSA ROW inspection fees, penalties and/or any and all fees associated with the permit. To register the contractor should contact the COSA ROW office at 210-207-6949.**
2. Question: Are there any work orders located over the Edwards Aquifer recharge zone?  
**Response: No.**
3. Question: Why does the bid proposal not include a pay item for by-pass?  
**Response: By-pass operations are incidental to other work and are addressed in Item No. 900 Reconstruction of Sanitary Sewer by Pipe-Bursting/Crushing Replacement, and Item No. 901 Reconstruction of Sanitary Sewer by Cured-In-Place Pipe.**
4. Question: Will the contractor be expected to perform work on lines that are in service?  
**Response: Yes. However, service interruptions shall be avoided or minimized during the performance of the work.**
5. Question: What are the requirements for proctor and density testing?  
**Response: Contractor shall refer to SAWS Standard specifications for testing requirements.**
6. Question: Which line item addresses select fill when required?  
**Response: Select fill is incidental to other work.**
7. Question: What is the reason behind the large quantity listed for pavement repair or replacement related work?  
**Response: The estimated quantity listed in the bid proposal is the amount of pavement repair the contractor may have to repair as required by the Contract Documents.**
8. Question: If a service re-connect is encountered during a point repair, which pay item will address the work performed?  
**Response: The work will be covered under Item 1103 Point Repairs and Obstruction removals.**
9. Question: What is the contract duration?  
**Response: 365 days.**
