### PART 1 - BIDDING AND CONTRACT REQUIREMENTS


- 1. INVITATION TO BIDDERS: Add the following paragraph after the fourth paragraph: "A non-mandatory site visit has been scheduled for the project. The site visit will be held on Monday, June 6, 2011, starting at 8:30 AM (CST). Bidders shall meet at the existing monitoring well site on County Road (CR) 123 northwest about 1/2 mile from Farm-to-Market (FM) 77 and CR 123 intersection."
- 2. INVITATION TO BIDDERS: DELETE the following sentence from the fifth paragraph "Sealed bids will be received by the Contract Administration Division, 2800 U.S. Hwy 281 North, Customer Center Building, Suite 171, San Antonio, Texas 78212, until 2:00 p.m., June 15, 2011." And REPLACE with "Sealed bids will be received by the Contract Administration Division, 2800 U.S. Hwy 281 North, Customer Center Building, Suite 171, San Antonio, Texas 78212, until 10 a.m., June 15, 2011."

ALL BIDDERS SHALL ACKNOWLEDGE RECEIPT OF ADDENDUM NO. 1 IN THE BID FORM AND BY HIS/HER SIGNATURE AFFIXED HERETO AND TO FILE SAME AS AN ATTACHMENT TO HIS/HER BID. BID FORMS SUBMITTED WITHOUT THIS ACKNOWLEDGEMENT WILL BE CONSIDERED INFORMAL.

# **CONTRACTOR QUESTIONS AND CLARIFICATIONS**

1. **Question:** Can the prime contractor be a company other than a water well driller as long as the driller meets all the job requirements?

Clarification: The Contractor is referred to the requirement in the SPECIAL CONDITIONS which states that "The Contractor shall perform Work with its own organization on at least 40% of the total original contract price". This requirement will remain. In addition, the experience requirements listed in the Bid Proposal shall apply.
