Good Faith Effort Plan (GFEP) FAQs

Q: Is the 20% SMWB goal mandatory?

A: No, but we ask prime contractors to do their best with good faith outreach efforts. If the goal is not met, proof of outreach efforts is required with the submittal.

- Q:What if I am having trouble finding SMWB subcontractors?
 - A: Please email the SMWVB Program Manager with the scopes of work you are seeking. You will receive lists of local SMWVB-certified firms to contact.
- Q:What if my business is SMWB-certified? Do I need to find SMWB subs?
 - A: If your firm is SMWVB-certified, you will most likely meet the goal. However, the GFEP is a required document, and a good faith outreach effort is still necessary.
- Q: Do I need to include all my subcontractors in the GFEP or just those that qualify towards the SMWB goal?
 - A: All subcontractors need to be included in the GFEP, even those that may not count towards the SMWB goal.
- Q:What if I have questions about the GFEP?
 - A: Please contact the SMWVB Program Manager at 210-233-3420, or at Marisol.Robles@saws.org. GFEP questions can be asked at any time before the submittal is due.



Bid Packet Preparation

- Electronic or Physical bid permitted. If electronic see Electronic Bid Opening Instructions for last day to request FTP site access.
- Utilize the Bid Packet Checklist within the specifications
 - Only limited items are required with the initial bid packet
- **Double check all** mathematical calculations and verify all extensions
- Addendums are acknowledged on the Bid Proposal
- Ensure Mobilization & Prep ROW Line Item does not exceed the percentage allowed
- Apparent low bidder must submit additional information within 24 hours of the bid opening to include:
 - Conflict of Interest Questionnaire, Proof of Insurability (Letter from Insurer or Sample Certificate of Insurance), Company Information Packet, Statement Regarding Ability to Complete the Project, W-9, Statement of Bidder's Experience, Detailed Baseline Schedule with NTP of November 15, 2021



Bid Packet Preparation (cont.)

- Bidder shall ensure that the 3 projects submitted on the Statement of Bidder's Experience form are:
 - Of similar size and scope as indicated on the check boxes
 - Completed by the bidder (submitting contractor)
 - Performed completed in the last 5 years
 - Owner references (entity bidder contracted with)
 - Verifiable with up-to-date contact information for the Owner
- Failure to complete the form properly may result in the bid being found non-responsive

Contract Requirements

Prevailing Wage Rate and Labor Standards – Section 2.10 of the General Conditions

- Payroll records are subject to review
- Contractors to utilize LCP Tracker
- Certified payroll to be submitted on weekly basis
- Contractors are responsible for sub-contractor payroll
- Late payrolls delay contractor payments from SAWS
- Wage decisions are included within the specifications
- Site visits are random and unannounced
- Interviews will be conducted and will be private & confidential
- All apprenticeship programs will need to be approved by Department of Labor prior to starting



Contract Requirements

- Insurance requirements are found in Section 5.7 of the GCs
 - Installation Floater coverage is required in lieu of Builder's
 Risk insurance
- Insurance must be compliant prior to executing the contract
- SAWS will ask for insurance prior to Board award to expedite execution of the contract
 - -Any deficiencies must be corrected prior to Board award
- Contractor must maintain insurance coverage during the construction of this Project



Project Background

- Water mains are being replaced due to age and condition.
- Also dead end water mains are being connected as part of the project.


Supplemental Conditions

- Liquidated damages for the purpose of this contract, will be assessed at \$510 per day.




VICINITY MAP








Suggested Phasing Plan






Merritt St. Site






Berry Hill Site






Scates Dr. Site






Marbach Rd. Site






Westpond Dr. Site






Concio St. Site






Horal Dr. Site

SC1. A Geotechnical Data Report is available for download.

SC6. Contractor shall contact CPS 2 week prior to entry onto the property.

- Maintain a 10-foot clearance to the distribution structures (tower).
- Excavation within 10 foot of CPS Energy tower foundations will not be allowed.
- **SC10.** Contractor shall finish the construction and restoration of the pipeline segment at Jamaica Street prior to starting any of the other project locations.
- **SC11.** Contractor shall not work on more than 2 project locations.
- SC16. Contractor shall perform SUE Quality Level A.
- SC17. Contractor shall field verify Google Fiber facility prior to construction.
- SC18. Temporarily relocate existing bridge at Concio.
- **SC19.** Remove steel reinforced concrete at Concio.

ITEM NO. SS 01030: Sequencing and Tie-In

> Sequencing and Tie-In are considered subsidiary to the work.

ITEM NO. SS 02550: Abandonment of Water Main and Appurtenances

> Grouting of abandoned water lines shall be measured by linear foot.

ITEM NO. SS 6001: Portable Changeable Message Sign

> This Item will be measured by each PCMS used regardless of duration.
