### Good Faith Effort Plan (GFEP) FAQs

- Q: Is the 21% SMWB goal mandatory?
   A: No, but we ask prime contractors to do their best with good faith outreach efforts. If the goal is not met, proof of outreach efforts is required with the submittal.
- Q:What if I am having trouble finding SMWB subcontractors?
   A:The SCTRCA has a search portal at <u>www.sctrca.sctrca.org</u>. Please make sure to include SAWS-specific parameters in your search. Contact Marisol Robles at <u>Marisol.Robles@saws.org</u> if assistance is needed.
- Q:What if my business is SMWB-certified? Do I need to find SMWB subs?
   A: If your firm is SMWB-certified, you will most likely meet the goal. However, the GFEP is a required document, and a good faith outreach effort is still necessary.
- Q: Do I need to include all my subcontractors in the GFEP or just those that qualify towards the SMWB goal?

A:All subcontractors need to be included in the GFEP, even those that may not count towards the SMWB goal.



### **Contract Requirements**

Prevailing Wage Rate and Labor Standards – Section 2.10 of the General Conditions

- Wage decisions are included within the specifications
- Contractors to utilize LCP Tracker
- Certified payroll to be submitted on weekly basis beginning on the start date indicated on the Notice to Proceed, even in non-performing weeks
- Contractors are responsible for sub-contractor payroll
- Late payrolls delay contractor payments, as well as release of retainage at the end of the project
- Payroll records are subject to review
- Site visits are random and unannounced
- Interviews will be conducted and will be private & confidential
- All apprenticeship programs will need to be approved by Department of Labor prior to starting work

- Contractor must ensure insurance is compliant for the duration of the contract
- Please note Special Condition SC.I regarding additional insured.







### **Bid Packet Preparation**

Apparent Low Bidder

- Notified by SAWS within 24 hours of Bid Opening to provide the following:
  - Conflict of Interest Questionnaire Form CIQ
  - Proof of Insurability
  - Company Information Packet
  - Statement regarding ability to complete the project
  - W-9
  - Statement of Bidder's Experience
  - \*And, if bid was submitted electronically without a Bid Bond:
  - Cashier's Check or Certified Check



- Ensure Statement of Bidder's Experience forms are complete and meet the following :
  - Projects submitted for each check box meet all requirements on each form
    - A-1 minimum of 2,000 LF of 24-inch (or greater) sanitary sewer main by CIPP
    - A-2 minimum of 3,000 LF of 72-inch (or greater) sanitary sewer main by CIPP (different than A-1)
    - A-3 installation of bypass pumping systems for large diameter sanitary sewers (24-inches and larger)
    - A-I,A-2 and A-3 Projects were completed between 2017-2022
  - Only Owner references are provided (such as City, County, etc. -not design engineer, prime contractor if sub work, etc.
    - References are valid and have been previously verified
  - Only project A-3 can be completed by the prime contractor OR a subcontractor

- Utilize the Bid Packet Checklist within the specifications
- Double check all mathematical calculations and verify all extensions
- Addendums are acknowledged on the Bid Proposal
  - Check the SAWS website regularly for addendum postings
  - It is possible to have multiple addendums
  - Known changes for addendums:
    - Response to Questions



#### MAKING SAN ANTONIO WATERFUI

- Pay close attention to the Mobilization and Preparation of ROW line items on the Bid Proposal as they are broken down <u>by site/location</u>
- Bidders <u>must also</u> provide the cost of the sites/locations and enter a subtotal for Mobilization and Preparation of ROW (all sites combined)
- Ensure Mobilization & Prep ROW do not exceed the percentages allowed once subtotaled
- When preparing the bid tab, SAWS will verify both the subtotals and total of site/location line items. If there is a discrepancy the subtotal provided by the Bidder will take precedence to correct the bid.

### **Bid Opening Procedures**

- Bids will be submitted using SAWS' electronic bid opening procedures
- Submission of electronic bids preferred using SAWS secure FTP site.
   Submit a request via email at least 24 hours before bid opening
- Or, Bidders may drop off a hard copy bid. Only required items.
  - Drop box is located at 2800 US Hwy 281 N, Customer Service Tower
    - Enter the first set of glass double doors
    - Insert into the black drop box on the wall on the left-hand side
- Late bids will not be accepted and will be returned unopened.
- Bid Opening will be handled via WebEx only; link found in IFB


