This addendum, applicable to the work associated with the above referenced Contract, is an amendment to the bidding documents and as such shall be a part of and included in the Contract. The original contract documents and any prior addenda remain in full force except as modified by the following, which shall take precedence over any contrary provisions in prior documents.

Questions and Answers:

The following written questions were received by SAWS following the May 20, 2014 pre-bid meeting. Responses to the questions are provided as follows:

Question 1: *“I was reviewing the bid package for the 2014 Annual Sanitary Sewer Main Point and Manhole Adjustments Construction Contract. I checked the SAWS specifications and wanted to discuss adding Sherwin-Williams products. I have enclosed product data pages for the Sherwin-Williams Cor-Cote SC Plus and SherFlex for the Epoxy and Polyurethane products. I will be in San Antonio the last week of May and would like to visit with you about adding Sherwin-Williams products to your specification.”*

Response: Products specified in the contract for coating manholes have been approved by the SAWS Product Standards Committee. Any other coating products to be added to the approved products list must first be approved by the Committee. Information about submitting an application to the Committee for considering a product is posted on the SAWS internet web site at http://www.saws.org/business_center/specs/product_submittal/.

Question 2: *“Good morning, I have downloaded the specifications for the 2014 Annual Sanitary Sewer Main Point Repair and Manhole Adjustments Construction Contract - Pkg 1 and 2 and would like to verify/confirm that there are no plans for the projects?”*

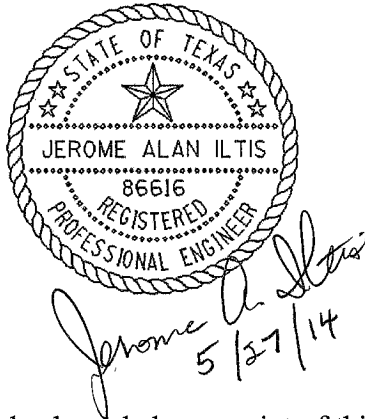
Response: There are no additional plans to download. There are, however, drawings of details in the referenced specifications that are part of the bid documents. SAWS Standard Drawing No. DD-852-03 is an example. SAWS standard construction specifications are posted on the SAWS internet web site at http://www.saws.org/business_center/specs/constspecs/.

Instructions to Bidders:

Because revisions to the SAWS standard construction specifications have been recently issued and are now effective, revisions to the Special Provisions and Proposal are necessary and are in progress. An addendum will follow. Consequently, deadlines for submitting questions, answering questions, and receiving bids are extended as follows:
