To Bidder of Record:

This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the Addendum number and issue date on the space provided in submitted copies of the bid proposal.

CHANGES TO THE SPECIFICATIONS

1. Invitation to Bidders, remove paragraph six(6) from Invitation to Bidders, Page IV and replace with the following:

Sealed bids will be received by the Contract Administration Division, 2800 U.S. Hwy 281 North, Customer Center Building, Suite 171, San Antonio, Texas 78212, until 3:00 PM (CT), July 19, 2016. Bids will then be publicly opened and read aloud in Contract Administration, CR-C137, Customer CenterBuilding, 2800 U.S. Hwy 281 North, San Antonio, Texas. Each bid must be accompanied by a cashier's check, certified check, or bid bond in an amount not less than five percent of the total bid price.

2. Bid Proposal, remove the BP-1 in its entirety and replace with the attached Bid Proposal.

Revision to line items 8, 9 and 26 to correspond with quantities shown in plans.

CHANGES TO THE PLANS

1. Sheet 2, remove from construction set and replace with the attached drawing.

The 24" water line tie-in to the existing 16" water line was shifted to the west by approximately 20 feet.

CHANGES TO ADDENDUM 1 QUESTIONS

1. It appears that several street crossings will be required on Highland Estates. One near the intersection of Borgfeld at the island, another at Aubrey Point and two at the cul-de-sac. Please identify any and all anticipated locations and requirements of the street restoration for Highland Estates street.

The streets within Highland Estates will only be constructed to the base course and will not be paved until after this project is completed. For this Project, the Contractor will be responsible for protecting the existing curbs, and compacting and backfilling in accordance to project specifications. A portion of the shoulder of Borgfeld will likely require removal and replacement subject to the means and methods utilized by the Contractor. The pavement section for Borgfeld consist of 6" moisture conditioned subgrade, 7" Type B Warm Mix Asphaltic Concrete (WMAC) (PG64-22), 2" Type C WMAC (PG70-22), and 2" Type C WMAC (PG70-22). Payment for this item is considered incidental to the 24" water main installation.

2. The plans show the 24" main to be installed outside the ROW for the majority of the run on Highland Estates. Since the ROW will be cut prior to this contract, that will leave the main to be installed in the centerline of a rock wall in many cases (reference street section). This may require the need to import fill and level up the wall as high as 10' in some areas and export the fill when complete. Can you add a bid item for this additional work?

A bid item for additional work will not be added. The limit of excavation being performed under a separate contract will extend 10 feet past the right of way, therefore the Contractor for this project should only be required to level up if he anticipates excavating further than 10 feet from the right of way.

Same issue as above, can you add a clearing bid item as additional trees may need to be remove for the 24" installation?

Item No. 101 Preparing Right of Way shall include the removal of any trees, stumps, bushes, etc.

3. The 24" main profiles on Highland Estates maybe misleading as to the actual depths of the pipe installation. The profile shows a depth from street level, however the main will be installed on the high side of the street outside the ROW and will be as deep as 20' in many areas. Please confirm the anticipated depths of installation should be taken from natural ground elevations and not street elevations.

The depth of the water main shall be taken from the street elevations shown on the plans in all instances except at drainage crossings shown on Sheet 2 (Sta.6+75 – Sta. 8+25), and Sheet 4 (Sta. 2+20- Sta. 2+75).

4. Reference the note on the plans that states that the contractor is to pay for the removal and relocation of the CPS Energy poles? Are these newly placed poles going to be relocated?

Poles within Borgfeld right of way are more or less 6' offset from the center of the 24" water main. Contractor shall coordinate with CPS if any bracing is necessary within the Borgfeld right of way but no poles are expected to be removed or replaced within this project. Any coordination and bracing will not be paid as a separate line item. Any poles shown on the plans within the Highland Estates Subdivision are not scheduled to be installed until after this project is completed.

5. Is this project sales tax exempt? Yes, this project is tax exempt.
