In a recent site visit SAWS staff recognized low lying areas that a portion of the fence will be built access this low lying area. Given this condition, a non-mandatory site visit has been added to the schedule for the benefit of the bidders to see this condition. SAWS also has added a "Drainage Area Fence Panel" fence detail and fence spec, which will allow water flow and any associated debris to pass through the site.

This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the Addendum number and issue date on the space provided in submitted copies of the bid proposal.

#### CHANGES TO THE SPECIFICATIONS

- 1. Remove and replace the **Invitation to Bidders** in its entirety with the revised **Invitation to Bidders** attached to this Addendum.
- 2. Remove and replace the **BID PROPOSAL** in its entirety with the revised **BID PROPOSAL** attached to this Addendum. This is the version that must be used by bidders submitting a bid for this Project.
- 3. Delete SC-2.1 BARBED WIRE of the Special Conditions and replace with the following section:

#### SC-2.1 DRAINAGE AREA FENCE PANEL

Approximately 50 LF of perimeter fence along the south side of the property, and 400 LF long the Judson road frontage, are low lying areas or drainage areas that at times may have water flow and / or standing water.

For the purposes of this solicitation, the Bid Items will include 450' of the 5,014 LF of fence as "Drainage Area Fence Panel".

The location of this 450 Linear Feet of fence shall be confirmed by SAWS on site with the selected contractor.

#### CHANGES TO THE PLANS

1. Insert "Drainage Area Fence Panel "as part of the drawings for the construction of fence in low water areas (Attachment III).

- 1. There will be a non-mandatory site visit January 11, 2016 at project site. For location see Attachments I & II.


