Sealed bids are requested by the San Antonio Water System for the construction of approximately 4,262 linear feet (LF) of 36-inch sewer outfall main and 1,716 LF of 15-inch gravity sewer main to be extended from the existing 36-inch sewer main near the intersection of Medio Dr and Talley Road for the **Westpointe West Offsite Sewer Extension – Phase I**, SAWS Job No. **18-1658**. The San Antonio Water System Master Plan and anticipated growth in this area requires the construction of a 36-inch outfall main as well as a series of 15-inch gravity sewer mains in order to supply services to the Medio Creek watershed.
