This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. RESPONSES TO QUESTIONS

1. The Plans file, downloaded from SAWS website, are size 17" X 11". Please verify that this is the original size. All the drawings showing a scale are off by a factor of 2 when compared to drawing that have a physical dimension. i.e. scales shown as 1" = 40' should be 1" = 80'. etc. i.e. 05S01 show the electrical building foundation to be 40x20, when using the 1/4" = 1'-0 shown on the electrical drawing the foundation dimensions are 20'x10'. The scale issue seems to be typical for all drawings

Response: The sheets in the plans file (pdf) on SAWS' website are 11" X 17" half-size, and are from the original 22" X 34" full-size. Please note that for the referenced plan sheet 05S01, the title block includes a 1" equivalent bar that also states "One Inch at Full Size If Not One Inch Scale Accordingly." Please note that this scaling note is included on each plan sheet with dimensional/scaling information. The respondent's understanding is correct for the referenced plan sheet 05S01. That is, when using the 1/4"= 1'-0 shown, there would be a required factor of 2, i.e. 1/4"= 2'-0 (or 1/8"= 1'0).

CLARIFICATIONS

1. The half size plans uploaded on SAWS website should be used by potential Bidders when preparing a bid for this project.

CHANGES TO THE SPECIFICATIONS

1. INVITATION TO BIDDERS, Page IV-1, remove the fifth and sixth paragraph and replace with the following:


