# Good Faith Effort Plan (GFEP) FAQs

- Q: Is the 20% SMWB goal mandatory?
  - A: No, but we ask prime contractors to do their best with good faith outreach efforts. If the goal is not met, proof of outreach efforts is required with the submittal.
- Q:What if I am having trouble finding SMWB subcontractors?
  - A: Please email the SMWVB Program Manager with the scopes of work you are seeking. You will receive lists of local SMWVB-certified firms to contact.
- Q:What if my business is SMWB-certified? Do I need to find SMWB subs?
  - A: If your firm is SMWVB-certified, you will most likely meet the goal. However, the GFEP is a required document, and a good faith outreach effort is still necessary.
- Q: Do I need to include all my subcontractors in the GFEP or just those that qualify towards the SMWB goal?
  - A: All subcontractors need to be included in the GFEP, even those that may not count towards the SMWB goal.
- Q:What if I have questions about the GFEP?

### Bid Packet Preparation

- Utilize the Bid Packet Checklist within the specifications
- Double check all mathematical calculations and verify all extensions
- Addendums are now acknowledged on the Bid Proposals
- Ensure Mob and Prep of ROW do not exceed the percentage
- References and contact information must be verified prior to submitting bid(s)



### Contract Requirements

Prevailing Wage Rate and Labor Standards – Section 2.10 of the General Conditions

- Certified payroll to be submitted on weekly basis
- Wage decisions are included within the specifications
- Contractors to utilize LCP Tracker
- Site visits are random and unannounced
- Interviews will be Conducted and will be private & confidential
- Payroll records are subject to review
- All apprenticeship programs will need to be approved by Department of Labor prior to starting
- Contractors are responsible for sub-contractor payroll
- Late payrolls delay contractor payments from SAWS




### Contract Requirements

- Insurance requirements are found in Section 5.7 of the GCs
  - Builder's Risk is replaced by Installation Floater coverage (see Supplemental Conditions)
  - Maintain insurance coverage during the construction of this Project
- Compliant prior to executing the contract
- Will ask for insurance prior to Board award to expedite execution of the contract
  - Any deficiencies must be corrected prior to Board award





### Contract Background

- Sealed bids are requested by the San Antonio Water System for the construction of approximately 670 feet of 24-inch and 36-inch existing sanitary sewer main via cured in place pipe and will rehabilitate or replace associated manholes.
- Project Fund will finance this expenditure included in the CY 2020.
- Project is part of the Consent Decree.
- Contractor is to become familiar with the plans, specifications, and project locations.

### Contract Background

#### **Special Conditions**

- Contractor to submit a completion report when the project is complete
  - Pre and post MPEG-I video and video logs
  - Any tests and/or submittals specified in the Contract Documents
- Payment
  - The unit price cost for items shall include all the necessary incidental work as subsidiary to the item unless otherwise specifically called out in the plans or approved by SAWS



### Contract Requirements

#### Supplemental Conditions

- Worksite
  - No excavation work of any kind may begin until authorized by SAWS
  - Preliminary work such as televising, utility investigation/potholing, setup and testing of bypass pumping may not begin until approval in writing by SAWS
- Consent Decree Notice Provisions
  - Retention of documents
  - Notification of events that may cause delay
  - Liability for stipulated penalties



### Contract Requirements

#### Supplemental Conditions

- Contractor shall perform the Work with its own organization on at least 40% of the total original contract price.
- Liquidated damages will be assessed as follows for final completion extending beyond contract time of all Project Phases:

Any days tallied after 42 days will be assessed as a Tier 6 rate.

- Roosevelt Avenue (compkey 984418)
  - CIPP of 410-ft of 36-inch Clay Tile Pipe
  - Manhole Rehabilitation
  - Service Line Replacement



# East Jones Ave.

• The identified point repair does not cross any know utilities, but it parallels and existing 15" storm sewer.

A service lateral replacement will cross a 12" water main

• A manhole is proposed to accommodate the bypass and avoid disturbance of the Broadway intersection.

A property is currently under construction. The Contractor shall coordinate the construction work






### North Cherry Street

- No excavation is anticipated aside from the work associated with the ring and cover replacement.
- Due to the location of the upstream manhole, the bypass will require multiple bypass locations and longer bypass pipe.





- Three service laterals are included for replacement. One could not be confirmed if is live from the CCTV. If it is not active, the service will not be replaced.
- The sewer main contains a slight horizontal bend. The approximate location is shown in the plan drawings.

### Roosevelt Avenue

- No point repairs are anticipated based on the available information.
- An allowance item for removal of failed clay tiles has been included. Refer to Item SS I 020.
- The brick upstream manhole is anticipated to be removed. If the Contractor can complete the CIPP with access from existing manhole, rehabilitation by Item 910 will be allowed.


