This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the Addendum number and issue date on the space provided in submitted copies of the bid proposal.

RESPONSE TO BIDDER QUESTION

1. Question: In the plans the type and diameter of the trees are called out on plan sheets pages 13 – 19, which I assume are for tree protection. Why is there not a bid item (COSA 801) for Tree and Landscape Protection.

Response: The tree call outs on the plan sheets are for tree protection. However, this cost shall be built into the Contractor's bid. There will be No Separate Pay Item (NSPI) for tree protection. See information later in this addendum.

MODIFICATION TO SPECIFICATIONS

1. Invitation to Bidders: Remove and replace the sixth paragraph with the following:

Due to the COVID-19 emergency and to protect the health of the public, SAWS is implementing new procedures for the submission of bids. Bids will be received either Electronically or through Sealed bids, until 11:00 AM 10:00 AM (CDT), Friday, May 1, 2020. Electronic bids will be received via the secure SAWS FTP site. Sealed bids will be received by Contract Administration, 2800 U.S. Hwy 281 North, Tower II, Customer Center Building, via a drop box located on the left wall when walking through the first set of double glass doors of the main Tower II entry on the north side of the building, San Antonio, Texas 78212. See the Electronic bids shall be accompanied by a bid bond in an amount not less than five percent of the total bid price. (Or, if providing SAWS with a cashier's check or certified check in an amount not less than five percent of the total bid price, SAWS will request this within 24 hours from the apparent low bidder. Sealed bids must be accompanied by a cashier's check, or bid bond in an amount not less than five percent of the total bid price. Bids will then be publicly opened and read aloud by Contract Administration via WebEx.

- 2. The Proposal Certification is being revised to include the number of project days. Remove and replace page PC-1 with the attached as included in this addendum. The updated version should be used by Bidders when submitting a response for the project. Failure to do so may result in the bid being found non-responsive and rejected.
- 3. Special Conditions Add the following section:

Coordination with VIA

Contractor shall coordinate work activities with VIA and their Contractor for proposed work along N. Alamo regarding sidewalks and bus stops. No separate pay item (NSPI) and no additional Contract Days will be afforded to the Contractor for days which are impacted by this work.

MODIFICATION TO PLANS FOR CONSTRUCTION

1. DWG B-G-04 ADD the following sentence to the end of Note 19:

"Tree Protection is integral to performance of the Work and will be No Separate Pay Item (NSPI)."

ATTACHMENT I

PROPOSAL CERTIFICATION

Accompanying this proposal is a Bid Bond or Certified or Cashier's Check payable to the Order of the San Antonio Water System for _______ dollars (\$_______), which amount represents five percent (5%) of the total bid price. Upon acceptance and award of the contract to the undersigned by the Owner, the undersigned shall execute standard San Antonio Water System Contract Documents and make Performance and Payment Bonds for the full amount of the contract within <u>10</u> calendar days after the award of the Contract to secure proper compliance with the terms and provisions of the contract, to insure and guarantee the work until final completion and acceptance, and the guarantee period stipulated, and to guarantee payment of all lawful claims for labor performed and materials furnished in the fulfillment of the contract.

It is anticipated that the Owner will provide written Authorization to Proceed within <u>30</u> days after the award of the contract.

The work called for in this Contract shall commence on the date indicated in the SAWS written Authorization to Proceed Under no circumstances shall the work commence prior to the date provided for in the SAWS issued, written Authorization to Proceed. Work shall be completed in full within <u>180</u> consecutive calendar days.

The undersigned further acknowledges compliance with "Wage and Labor Standard Provisions" of this contract and the use of the Blue Book rental rates for establishment of equipment rental rates whether owned or leased during the course of this Contract.

In completing the work contained in this proposal the undersigned certifies that bidder's practices and policies do not discriminate on the grounds of race, color, religion, sex or national origin and that the bidder will affirmatively cooperate in the implementation of these policies and practices.
