This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the Addendum number and issue date on the space provided in submitted copies of the bid proposal.

RESPONSES TO QUESTIONS

1. Was there any reason or design changes that warranted rejection of all bidders?

The rejection of bidders was due to a change of material within the design. The change of material required a change of descriptions and estimate towards bid items.

2. As well, the qualification statement requests three project within the past five years for laying DI. As you know, less than 10% of SAWS water projects are DI, and almost no surrounding municipalities install DI. Are three projects necessary to qualify to bid this project?

Yes, three (3) projects are required to qualify to bid this project.

CHANGES TO THE SPECIFICATIONS

3. The deadline for bid packets has been extended to December 21, 2021. Remove Paragraph six, through eight (6, 7, 8) from the Invitation to Bidders, Page IV-1 and replace with the following:

Due to the COVID-19 emergency and to protect the health of the public, SAWS is implementing new procedures for the submission of bids. Bids will be received either Electronically or through Sealed bids, until 1:00 PM (CDT), December 21, 2021. Electronic bids will be received via the secure SAWS FTP site. Sealed bids will be received by Contract Administration, 2800 U.S. Hwy 281 North, Tower II, Customer Center Building, via a drop box located on the left wall when walking through the first set of double glass doors of the main Tower II entry on the north side of the building, San Antonio, Texas 78212. See the Electronic Bid Opening Instructions attachment for additional information regarding an electronic bid submittal. Electronic bids shall be accompanied by a bid bond in an amount not less than five percent of the total bid price. (Or, if providing SAWS with a cashier's check or certified check in an amount not less than five percent of the total bid price, SAWS will request this within 24 hours from the apparent low bidder. Sealed bids must be accompanied by a cashier's check, certified check, or bid bond in an amount not less than five percent of the total bid price. Bids will then be publicly opened and read aloud by Contract Administration via WebEx.

If Bidders intend to submit bids electronically, Bidders will need to submit a request by December 20, 2021 by 1:00 PM CDT to receive access to the File Transfer Protocol (FTP) site via email to Stella.Manzello@saws.org. Bidder's email requesting access to the FTP site shall provide the legal name of Bidder's company and the intended recipient's email address and phone number. No requests for FTP site access will be accepted after December 20, 2021 by 1:00 PM (CDT).

Bid opening WebEx meeting will be held at 1:00 PM (CDT) on December 21, 2021.
