This addendum, applicable to work referenced above, is an amendment to the bidding documents and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the addendum number and issue date in the space provided in the submitted bid proposal.

RESPONSES TO QUESTIONS

1. Question: Is SAWS specifying HDPE pipe as a means of cost savings or for geo tech reasons for this project? If for cost savings, will SAWS consider a add alternate for PVC to ensure the most competitive and complete bid? DI fittings maybe considered incidental to the Pipe if needed to avoid plan revisions?

Response: HDPE pipe material was the selected material for this project during design. SAWS will not consider using PVC pipe material in lieu of HDPE pipe for this project. Please see Changes to Specifications number 1.

2. Question: Under statement of bidders experience, will SAWS consider removing the mandate of type of material used (HDPE), and maintain projects of similar scope to suffice this requirement. Due to the limited amount of open cut HDPE water main in residential areas constructed in recent years within the SAWS system. This will allow more local contractors to qualify and bid on this project.

Response: See updated "Statement of Bidder's Experience" included with this addendum.

3. Question: Will SAWS accept PVC as an alternative on North San Felipe, much like they utilized on San Gabriel new water main project earlier this year a few blocks away, if the contractor feels it will be a cost savings to SAWS?

Response: SAWS will not consider using PVC or DI pipe material in lieu of HDPE pipe for this project.

4. Question: On the Statement of Bidder's Experience A-1, A-2 & A-3, will SAWS remove the HDPE from description and have it read 8"water main installed by open cut and leave the remaining as written.

Response: See updated "Statement of Bidder's Experience" included with this addendum. Please see Changes to Specifications number 1.

5. If we have not specifically installed HDPE Water Main, does that disqualify us from being able to be awarded this project?

Response: Please see Changes to Specifications number 1 for revised Statement of Bidder's Experience form.

Bidders who wish to submit a proposal for this project must be able to provide projects for A-1, A-2 and A-3 on the revised Statement of Bidder Experience form attached to this Addendum ensuring that each project meets all of the requirements (each check box) and that they can provide valid, previously verified Owner references.

CHANGES TO SPECIFICATIONS

1. Remove the Statement of Bidder's experience form (SBE-1-3) in its entirety and replace with the revised Statement of Bidder's experience (SBE-1-3) attached to this addendum. Bidders shall use this version of the Statement of Bidder's experience forms when submitting a bid for this project. Failure to use the revised forms may result in the Bidder being found non-responsive.

CLARIFICATIONS

1. Contract A-1 must have been completed by the Bidder. Contracts A-2 and A-3 may be completed by the Prime or Subcontractor.
