- For purposes of determining the value of the Work self performed, the amount shall include all materials incorporated into the Work where the majority of the value of the Work involved in incorporating the material is performed by the Contractor's own Organization, including wholly owned subsidiary; and
- Labor provided by staff leasing firms licensed under Chapter 91 of the Texas Labor code for non supervisory personnel if the contractor or wholly owned subsidiary maintains direct control over the labor.

The remaining sections of Article IV shall remain the same."



#### SPECIAL CONDITIONS

#### SC.1 Miscellaneous

- SC.1.1 <u>Incidental Construction Items</u>. All items called out on the construction drawings or within the specifications which are not itemized in the bid proposal section of these documents shall be considered incidental to the cost of the project.
- SC.1.2 Contractor's Project Experience. The Contractor must demonstrate that they have successfully completed three (3) projects similar in scope, complexity, and cost within the last five (5) years. More specifically, the three (3) successfully completed projects must have included the installation of large diameter (greater than 54-inch) fiberglass reinforced pipe (FRP) that conveys municipal wastewater similar in scope to this project. The Contractor shall demonstrate experience with boring, jacking or tunneling large diameter (greater than 60-inch). The Contractor shall also demonstrate experience with the construction of multi-barrel siphon structures containing large diameter (48-inch and greater) barrels.
- SC.1.3 **INSTRUCTIONS TO BIDDERS:** Page IB-7, replaces Paragraph 23 with the following:
