III. PROJECT DISCUSSION

1. Contract is for construction of various unspecified water mains by open cut construction methods.
2. Duration of the Contract is 365 Calendar Days or until funds are exhausted, whichever comes first.
3. Addendum for Supplemental Conditions will be posted regarding Contractor Responsibility with COSA ROW permitting. (See Addendum No.1 posted October 30, 2013)
4. Bid Opening is November 5, 2013 at 10:30 a.m.

6. Answers to questions will be posted to web site by 4:00 PM on November 1, 2013, as a separate document or included as part of an addendum.
7. Estimated cost is \$3 Million.
8. Be familiar with Instructions to Bidders, Special Conditions, Supplemental Conditions, SAWS standard specifications and specifications of this contract.

To assist with bidder evaluation, items such as complete financial statements, statement regarding ability to complete the project within the schedule with existing commitments, record of similar projects, etc. will need to be submitted by the apparent low bidder. These requirements can be found in the contract documents. Per the Special Conditions these are to be submitted with the bid.

1. Item 1030 "Pressure Reducing Valve Assembly complete in vault (6"-12") SCADA Fitted" is to be in accordance with the Pressure Reducing Valve Assembly Details in the bid documents and should consist of any additional components necessary to be compatible with SAWS SCADA System including but not limited to electrical, instrumentation, SCADA, antenna, transmitter and controls. See Section 1030.11 Measurement and Payment of Special Specification Item No. 1030.

2. The Rental Rate Blue Book and it's R1 (Rate Adjustment Factor) and R2 (Regional Adjustment Factor) in the Hourly Rate formula of Section 4 of the Supplemental Conditions are nationally printed rates and can be obtained from Equipment Watch.
