RESPONSES:

1. **Site inspections-I have visited the main headquarters site-however it has been probably 18+ months ago. I am based in San Antonio, and would like to know if I can do quick site inspection next week in order to understand each location, and know exactly what would be involved for delivery, and making sure each site is properly set up for power needs, possible internet needs, and TV service.**

RESPONSE: Non-mandatory site visit. Date: October 9, 2019 at 10:00a.m. SAWS Headquarters, 2800 U.S. Hwy 281N, San Antonio, TX 78212.

2. **Can you please tell us your TV provider? It will make a difference as we offer several pieces of hardware, and help clients source the best alternative (DirectTV, Spectrum, AT&T, etc.)**

RESPONSE: Yes, we have Spectrum at this time.

3. **Can we provide more than one bid option? Technology is evolving very rapidly in the area of computing, and tracking systems for Corporate Wellness.**

RESPONSE: Yes, but must submit separate bid packages.

4. **The Treadmills and ellipticals ask for TV compatibility, however the Recumbent bikes do not list specifications. Can you please clarify?**

RESPONSE: No, TV is required for the bike, clear display screen.

5. **With the Wi-fi access points installed by SAWS--employees are opened up to a large software suite with PRECOR no charge to track their personal workouts. Can you please confirm you will have installed?**

RESPONSE: Corporate Wi-fi is available in the fitness center.

6. **We sell standard air driven rowers which require no power, and we also sell rowers with virtual programs with internet connectivity--great fun. However, we have**

never seen or sold rowers with TVs or personal viewing screens. Personal viewing system are requested-is this a error?

RESPONSE: This was an error. Rowers do not require TV or person viewing screens.

7. Treadmills list a spec of dual action, equal with converging? We have never heard of a converging treadmill. PRECOR has a patent on converging Elliptical, is that desirable?

RESPONSE: Yes, SAWS will consider a converging elliptical.

8. The bid does not ask about cardio equipment for employees with disabilities-such as a upper body bike that is wheel-chair accessible-would you like to add this?

RESPONSE: No.

9. You mention a cross ramp for ellipticals, would you want an adjustable cross-ramp that allows a user to target specific muscle groups? Our elliptical adjusts such as a treadmill can adjust the angle that you work out on. Our cross ramp adjusts from 0 to 40% incline.

RESPONSE: Yes, SAWS will consider an adjustable cross-ramp as described.

10. Lastly, Can you please advise if the system request is a 2 stack, Functional Crossover? In commercial fitness, "dual pulley" general comes to mean a 2 stack cable crossover with a pull up station. Dual referring to two. The description on bid references sealed bearings for Bicep Curl, Tricep Extension, Leg Extension, Leg Curl, etc. which are types of individual machines, not part of a dual pulley. Please refer to PRECOR FTS Glide Dual Pulley attached for representative example. This is a piece that also helps the SAWS facility offer an ADA compliant strength training modality.

RESPONSE: Yes, System request is a 2 stack functional crossover.
