- 2. Regarding the Price Schedule on Page 14, specifically item 14, what size dishes are these conversion kits going to be mounted to?**

Response: *All of the dishes are 3 foot. The model of the existing dishes is Radio Waves HP3-11 with an Exalt mount on them.*

- 3. In regards to the Price Schedule you have listed part# EXA-ADPT. Can you tell me what size the existing 11 GHz antennas are (2ft, 3ft or 4ft) so we can make sure we have the right part#?**

Response: *All of the dishes are 3 foot. The model of the existing dishes is Radio Waves HP3-11 with an Exalt mount on them.*
