Question: Can a Bidder submit a different combination system that the other units they are bidding?

Answer: No, all units must be from the same manufacture.

Question: When should requests for approved equals be submitted?

Answer: Approved equals should be submitted through the bid submittal, SAWS reserves the right

to request samples from the vendors and the vendors must comply with 48 hrs.

Question: Are self sustaining seats the same as soft close?

Answer: Yes.

Question: Can alternate products be included on the same bid document?

Answer: No, alternate items can be bid however each alternate must be included in a separate bid

package.

Question: When should good, better, and best seat, wax ring, and bolt samples be submitted?

Answer: They should be submitted on bid day.

Question: Under the section 5.0 Warranty Item 5.1 Line 4 refers to what we call operations and maintenance

manuals.

Does this need to be included at bid time or after award of contract? The section that the manufacturer furnished for this is 160 pages long. That would be 7 times 160 in each optional

package.

Answer: Operations and maintenance manuals do need to be submitted with each copy of the the

bid. However these may be submitted on a CD formatted to open with MS Office, or Adobe

Acrobat software.

Clarifications:

Only one price proposal needs to be included with the bid, and it must be submitted with the bid

in its own sealed envelope clearly marked price proposal.

Prices must remain firm throughout the duration of the contract period.
