This **Addendum 2** is issued to make changes as documented herein to the original bid sent to you on April 5, 2016. All other requirements, terms and conditions of the original bid remain the same.

Revisions to Specifications

Under Section 1.9 on Page 18 of 49, delete the paragraph in its entirety and replace with the following:

1.9 WARRANTY

- A. Manufacturer shall provide a written one year standard warranty from the date of use of the mechanically cleaned bar screen and washer compactor equipment to guarantee that there shall be no defects in material or workmanship in any item supplied.
- B. Manufacturer (or supplier) will pay all costs for warranty repairs during the standard warranty period. Coverage will include, but is not limited to, parts, labor, freight, and mobilization charges.
- C. The manufacturer or the manufacturer's representative has 48 hours to arrive onsite to assess the failure from the time the manufacturer was notified of the failure.
- D. The manufacturer has no more than 30 (thirty) calendar days to provide all required parts and repair the equipment to full working order.
- E. The number of warranty claims is unlimited during the warranty period.

IT IS NOT NECESSARY TO RETURN THIS ADDENDUM TOGETHER WITH YOUR BID.
