I. QUESTIONS: General

- 1) The existing perimeter fence and gates are 7’ high with 1’ of barbed wire. The drawing in the bid pack of the Jamieson gate shows the gate as 6’ high with 1’ of barbed wire. Are we are to bid on all fence and gates to match the existing 7’ + 1’, or 6’ +1’?

Response: 6’ high with 1’ of barbed wire.

- 2) Page 17 of the bid pack, Price Schedule item 1 has in the description “Install two (2) HySecurity DC-10F Operators”, in the Quantity column, quantity is listed as 2, which would total 4 operators. Please clarify, should the description be changed to “Install 1” so the unit price reflects 1 operator with a quantity of 2, or should the unit price be for installation of both operators, with a quantity of 1?

Response: The quantity in the price schedule is correct as we are asking for a total of two (2) Hy Security DC-10F operators and not four (4). Please include the price of labor, disposal, installation and all other related charges within the price of the item(s).

- 3) There does not appear to be an item in the Price schedule to capture the chain link fence lines that connect the existing gate locations to the new gate locations?

Response: The chain link fence will not be included in the bid.

- 4) Would need to install any necessary fire access equipment (i.e. Knox key switch, chain-drop kits, etc.)?

Response: No.
