- 4) **Question:** Scope of Work, Item 9: Delivery, RF(x) Page No. 13 Contractor is required to keep a small surplus inventory of 5 standard laptops (un-etched) and desktops.
 - a. Are 5 laptops and 5 desktops required (for a total of 10)?
 - b. Will the surplus inventory need to be maintained at the required amounts for the life of the contract?
 - c. If the surplus inventory must be maintained, then when a laptop or desktop is shipped from surplus, how is it to be replaced in the inventory?
 - d. Why are the surplus laptops required to be un-etched?

Response: Contractor is required to keep a small surplus inventory of 5 standard laptops (un-etched) and desktops.

- d. SAWS intends to have these items on hand in case an emergency need arises. Due to the changing environment we want to be able to update the surplus items if or when models change and not be locked into buying an older etched model.
