This Addendum no. 1 is being issued for Bid no. 18-18024 for General Easement and Brush Clearing. This addendum is being used to provide answer and clarification to questions submitted. Additional, the Bid Bond requirement is being changed to reflect SAWS actual Annual budget amount. The following paragraph for Bid Bond is being revised:
12. Bid Bond: All bids must be accompanied by Certified or Cashier's Check or an approved Bid Bond in the amount of not less than five percent (5\%) of SAWS budget amount of $\mathbf{\$ 1 0 0 , 0 0 0 . 0 0}$, payable without recourse to the San Antonio Water System. Surety shall provide a copy of the Power of Attorney authorizing the Executing Agent the authority to execute the bid bond documents and bind the Surety to the bid bond conditions. The bid bond shall have a corporate Surety that is licensed to conduct business in Texas and authorized to underwrite bonds in the amount of the bid bond. Submission of an Individual Surety is not acceptable for purposes of bonding a bid bond. Bid Bonds, Certified or Cashier's checks will be retained for the first, second, and third lowest bidders until the contract is executed.

Question submitted:
