ITEM C

19,000 GVWR (MINIMUM) 84" CA, 4X2, REGULAR-CAB, CAB- CHASSIS WITH INSTALLED REINFORCED UTILITY BODY AND 6,000-POUND CORNER MOUNTED CRANE

ITEM D

19,000 GVWR (MINIMUM) 4X2, REGULAR-CAB, CAB- CHASSIS WITH INSTALLED PLATFORM BED

On both items change specification Item 45 on page 23 of 70 and Item 45 on page 34 of 70 as follows:

From:

45. 6.6 liter Diesel engine (minimum), 325 horsepower (minimum) at 750-ft lbs. of torque (minimum).

TO:

45. 6.6 liter Diesel engine (minimum), 325 horsepower (minimum) at 700-ft lbs. of torque (minimum).
