1. **Glove A-2 Nitrile Gloves, were there any price increases over the course of the contract for this item?**

Response: *No price increase*

2. **Group 2 – Glove A-2 Nitrile Gloves, what is the current make/model you are currently purchasing and at what price?**

3. **Section A-4. Frogwear/Global glove #180F has no technical data listed, which means it has not been CE scored. What is the application for this glove??**

Response: *The application of this glove is for personal protective glove wear to be worn by San Antonio Water System (SAWS) employees for use when hands may be immersed in water or sewage and are doing lifting or pulling activities, or may be scratched or bumped during mechanical processes. For use when dexterity is less important and avoiding wet hands is more important.*

4. **A3 – Cowhide 8212 glove. Approved for Group 3?**

Response: *Yes*

5. **A8 – 3734TPR Machinist gloves. Approved for Group 8?**

Response: *yes*

6. **A2 –Nitrile Gloves, Diamond Grippaz DNFBK. Approved for Group 2?**

Response: *yes*

7. **A2 –Nitrile Gloves, Powder-Free Glove. Approved for Group 2?**

Response: *yes, as long as they meet the rest of the specs.*

8. **Please confirm the delivery locations have a loading dock and no inside delivery or lift gate is necessary.**

Response: *Delivery locations do not have a loading dock. Each of the locations is equipped with a forklift to unload orders. All order to be unloaded must be brought to the rear of enclosed trucks/trailers for unloading.*

Response: *We are omitting x-small glove in Price Schedule, section A-4. You may delete the x-small from your Price Schedule submittal for A-4. If included, SAWS will not consider the x-small quoted prices when awarding this contract.*
