1. Answer vendor questions and provide clarifications to the bid. See the questions and answers below.

Q1: <u>Line Items 1 & 8 Closed Industrial Steel Shelving</u>. Line Item 1 does not list any requested dividers per unit as Line Item 8 lists 21 dividers per unit?

A1: This is correct, only the shelving listed as Line Item #8 requires dividers.

Q2: <u>Line Items 2 & 7 Rack Bulk Shelving w/ Galvanized Panels</u>. Both line items read wire decking on substitute sheets but list Galvanized-panel decking in verbiage. Is this to be galvanized wire decking or galvanized steel panel decking?

A2: Both of line items for the rack Bulk Shelving require Galvanized panels. Updated substitution sheets for Line #2 Drawing Identifier SH-3B and Line #7 Drawing Identifier SH-3G are included in this Addendum #3.

Q3: Beams to allow for cross bar and decking. Clarification: Is the bid not to include these items? What type of decking are the beams to allow for?

A3: Revise the specification for all pallet shelving as follows:

• (Changed from) Current specification says: High strength 15 gauge steel step beams to allow for cross bars and decking.

(Changed to) Revised specification to read: High strength 15 gauge steel step beams to allow for cross bars (pallet supports) or decking.

• Add the following requirement to the specification: Each pallet shelving unit shall come with six (6) steel double flanged pallet supports per shelving level.

Q4: SH-3B bid requests 19ea, matches quantity in drawings, attached Price Schedule reads 11ea? A4: Groups 1, 2 and 3 total 30 each. Material specifications for drawing Line #2 SH-3B have been updated to reflect the actual total.

Q5: SH-3D bid requests 28ea but drawings only show 22ea? Attached Price Schedule reads 29ea? A5: Drawing total is 22 each. We want to have a few extra in the event that installation frees up additional space. Price schedule and Drawing Identifier Line #4 SH-3D in the Material Specifications have been updated.

Q6: SH-3E bid requests 40ea but drawings only show 39ea? Attached Price Schedule reads 39ea? A6: Drawing total is 40 each. We want to have extra in the event that installation frees up additional space. Price schedule has been updated.

Q7: SH-3F bid requests 12ea but drawings only show 6ea? Attached Price Schedule reads 5ea? A7: Price schedule and drawing are correct at 5 each. Drawing shows 5 each. Material Specifications for Drawing Identifier Line # 6 SH-3F have been updated.

Q8: SH-3G bid requests 12ea, matches quantity in drawings, attached Price Schedule reads 14ea? A8: Drawing total is 12 each. We want to have a few extra in the event that installation frees up additional space. Price schedule and Material Specifications for Drawing Identifier Line # 7 have been updated.

Q9: There's some information missing in the description of the shelving DRAWING IDENTIFIER SH-3H, CLOSED INDUSTRIAL STEEL SHELVING WITH DIVIDERS. We need to know the size of the dividers and what type, bolted or sliding dividers. A9: The shelving dividers are to be the bolted type and must be twelve (12) inches tall and the depth of the shelf. Material Specifications for Drawing Identifier Line # 8 have been updated.

Q10: Also, do you want row spacers for the back to back rows of pallet rack. If yes what size? A10: No, row spacers are not required.

- 2. Revise the bid opening date from June 3, 2019 by 3:00 PM to June 10, 2019 by 3:00 PM.
- 3. Update the due date for Item #7, Page 12 of 43. The due date for questions is changed **from** May 24, 2019 by 4:00 PM to June 4, 2019 by 4:00 PM.
- 4. Update the due date for Item 9. Page 14 of 43. Substitution Request Form (Attachment A) for request for approved equals is changed **from** May 24, 2019 by 4:00 PM **to** June 4, 2019 by 4:00 PM.
- 5. Provide an updated Excel Price Schedule document. Complete the document and provide a hard copy with your bid submission. The electronic copy will be requested from the lowest responsible bidder.
- 6. Provide updated Substitution Request Forms (Attachment A) for Drawing Identifier Line #2 and Drawing Identifier Line #7.
