1. Provide questions and responses.

IT IS NECESSARY TO RETURN THIS ADDENDUM 1 AS PART OF YOUR BID SUBMISSION

QUESTIONS AND RESPONSES

1. Can the framing for the booth be constructed of steel instead of aluminum?

Response: Yes, as long as the trailer meets the following specifications for towing:

- The mounted guard booth dimensions shall be 4' foot wide X 6' foot tall.
- Deck width shall be a minimum 60" inches between the wheels.
- Deck length shall be a minimum 10' foot.
- Trailer overall length shall not exceed 16' feet to include deck and tongue.
- Trailer deck flooring shall be treated wood bolted to the trailer frame.
- The trailer tongue shall be constructed of high-quality steel and shall have a positive tongue weight when empty.
- Unit shall include a minimum 2" inch ball style coupler / hitch. The 2" inch minimum coupler shall meet or exceed the gross trailer weight rating.

2. What material is used for the roof overhang?

Response: Same material the roof of the trailer is constructed, no specific material stated.

3. How much weight will be inside booth?

Response: A max of 900 pounds.

4. What height would you like the window to be in door?

Response: No garter than 41" inches from the bottom of the door 36" inches tall.

5. Can you provide any info on the forklift lift capabilities? Did you want fork pockets?

Response: The base frame shall be able to withstand lifting the booth with a forklift. Does not need pockets, but can have them.

6. Any spec requirements for the trailer chassis? Distance between rails and gusset locations?

Response: Trailer shall be of the following dimensions and specifications:

- Deck width shall be a minimum 60" inches between the wheels.
- Deck length shall be a minimum 10' foot.
- Trailer overall length shall not exceed 16' feet to include deck and tongue.
- Trailer deck flooring shall be treated wood bolted to the trailer frame.
