This addendum is being issued to revise and clarify the scope of the repair services being requested in Bid # 12-1281.

At San Antonio Water System Chilled Water Plant # 325 the following additions are to be made to the scope of work:

- Install a patch of 16 gauge galvanized metal over the corrosion located below the access panel above the cool water basin. Patch is to extend a minimum of 3 inches around existing corroded hole. Patch is to be secured to existing structure using stainless steel 304 bolts or rivets.
- Install an industrial grade fiberglass grate above the recess in the cold water basin. Grate must have a minimum strength rating of 719 pounds with a safety factor of 2. Grate shall cover recess by a minimum of 6 inches on each side. Grate shall be secured with stainless steel 304 hardware and fasteners.

To clarify the items that were discussed:

- Please bid the replacement of the hot water basin, repair of the basin will not be considered at this time.
- The chiller at San Antonio Water System Chilled Water Plant # 1625 cannot be taken out of service until chiller #2 at that site is returned to operation.
