But please note that SAWS currently owns 14 Oracle processor licenses and this purchase request is for two additional processor licenses plus first year support for these two additional processor licenses. Even though Oracle has discontinued the Configuration Management Pack, its purchase should be allowed since our current 14 processor licenses are configured with the Configuration Management Pack.
