II. **Questions:**

Question 1: On Price Schedule, under Item 2, line item 26976 (fire extinguisher 6 year maintenance. On pg. 13 under specifications: recharge is included in the 6 year maintenance. How do we calculate recharging cost if extinguisher are different sizes, thus different rate?

Answer: A revised price schedule is attached to this Addendum 1 to address this issue.

Question 2: On page 16 of the Price Schedule, under Item 1: Recharge Service for #'s 26966-26969, will canisters have agent and only need to be recharged? (No need to refill empty canisters)

Answer: Only canisters that do not pass the test will be re-charged.

Question 3: Under Item 3, line 34972, DOT requalification. What does DOT stands for?

Answer: DOT Hydro-Testing

Question 4: Line Item 26977, what are you asking on fire extinguisher test D/C?

Answer: The cost depends on the amount of dry chemical or compound in the fire extinguisher. See revised price schedule.

Question 5: Line Item 26981, what are you asking for on fire extinguisher pressure test?

Answer: That fire extinguisher will be hydro-tested depending on their age. See revised price schedule.

Question 5: On the price schedule, under Item 2, No. 26977, what does "D/C" stands for?

Answer: Dry Chemical.

Question 6: On the price schedule, under Item 2, No. 26979, what does "W/P" stands for?

Answer: Water Pressure

Question 7: Under Item 2, Maintenance & Testing, test charges varies according to their size. How should we price each of them if there is no available size on the price schedule?
