### I. <u>Deadline Extension:</u>

Deadline of submission is extended until Friday, January 11, 2013 at 3:00 pm.

### **II. Specification & Questions Clarification:**

Under Specification, letter B, Recharge Service and C, Six (6) Year Maintenance.

- a. Recharge service shall include recharge process on canisters with agent only. Vendor shall provide pricing for recharge service under Item1, of the revised Price Schedule of Addendum II.
- b. All maintenance and testing under Item 2, Price Schedule of Addendum II only covers maintenance and testing (no recharge). If fire extinguishers require recharge after testing, vendor shall charge SAWS separately for the recharge service based on vendor provided pricing under Item 1, Price Schedule.

On questions answered as part of Addendum 1, clarification as follows;

a. **Question 1:** On Price Schedule, under Item 2, line item 26976 (fire extinguisher 6 year maintenance. On pg. 13 under specifications: recharge is included in the 6 year maintenance. How do we calculate recharging cost if extinguisher are different sizes, thus different rate?

**Answer:** Item No. 26976, Fire Extinguisher 6 Year Maintenance only covers inspection and testing. If a recharge is needed after testing, vendor shall charge SAWS, depending on the sizes, based on the provided pricing under Item 1.

b. **Question 7:** Under Item 2, Maintenance & Testing, test charges varies according to their size. How should we price each of them if there is no available size on the price schedule?

**Answer:** Maintenance and Testing under Item 2, shall only cover maintenance and testing. Maintenance and testing shall be of the same charge regardless of the fire extinguisher sizes. If a recharge is needed after testing, vendor shall charge SAWS, depending on the sizes, based on the provided pricing under Item 1.
