1. Please confirm how large the tank can be for the delivery to both locations. We can provide you better pricing if we are hauling a larger load and dropping a larger load.

<u>Response</u>: The tank at Riverside is 75 Gallon and the tanks at Medio are 8800 Gallons each. Bothe sites are accessible by straight truck or tractor trailer. The only restriction may be the weight limits on the streets leading to the sites but both locations have received deliveries from tractor trailer tanker rigs.

2. Is a Bid Bond required?

<u>**Response:**</u> No, however, the awarded contractor is responsible for providing insurance as required on page 17 - 22.

3. Is a Performance Bond required?

<u>**Response:**</u> No, however, the awarded contractor is responsible for providing insurance as required on page 17 - 22.

4. Do prices have to remain firm for the first year?

Response: Yes.

5. Can prices be adjusted at each one year extension?

<u>Response</u>: Yes, provided that the contractor provides sufficient documentation and evidence that pricing has changed significantly enough to warrant a price change.

6. Will SAWS consider a larger tank at the Riverside Golf Course?

Response: At this time, no.

7. Can the hose connection at Medio Creek be changed to a 2" Camlock fitting?

<u>*Response:*</u> No. The awarded contractor will be expected to provide the necessary connectors to tie into the existing connection.

8. Will deliveries be scheduled or unscheduled?

<u>*Response:*</u> Deliveries will be made between 08:00 am and 3:00 pm, Monday thru Friday, except for SAWS holidays.

9. The tanks at Medio are inside the building and the delivery connection is outside the building would someone be available to watch tank levels and communicate them to the driver?

Response: A SAWS employee will be with the driver during all deliveries at both sites.

10. The fill connections that are inside the SS boxes will have minor leaks every time the hose is disconnected. Unless the box is made out of titanium they need to be plastic coated or they will corrode away in a very short time. The same may also apply to metals inside the building but to a lesser degree. Will you be changing these boxes or will we need to provide replacement boxes when they corrode?

Response: This will be corrected before the contract is awarded.

11. The tanks being located inside the building and the fill connections outside the building the driver cannot observe tank levels while filling the tanks. The driver is required to stay with the truck once the fill is started. SAWS mentioned that there will be an employee with the driver but there is still the communication lag time that could cause a spill. An easy fix to this problem would be to install a remote display off the level instruments on the side of the building near the fill point. Can SAWS install a remote display so we would not have to bother any SAWS staff?

Response: A remote display will be installed before the contract is awarded.

12. Is it possible to split this contract into two contracts? Riverside will require us to provide a different truck and driver in order to be cost effective.

<u>Response</u>: At this time no. SAWS needs historical data to make a determination on frequency and usage in order to determine what will be best.

13. Will an eyewash station and safety shower be available at the Riverside Golf course delivery site?

Response: A portable Eye wash will be installed before the contract is in place.

14. Will an operator be on hand every time while loading bleach at the Riverside Golf Course?

Response: See #9.

15. Will an operator be on hand every time while loading bleach at Medio Creek to monitor and relay the tank level to driver?

Response: See #9.

16. Are the tanks at Medio Creek equipped with a vent on top of each tank?

Response: Yes.

17. Will the stainless steel box holding the hose connections at Medio Creek be changed? Stainless steel is not compatible with bleach.

Response: See #10.
