***** This Addendum 5 is issued to make the following changes to RFP 16-16120:

1. Provided are responses to the following questions:

Question 1: Who will be responsible for writing the interface with the SAWS billing software?

Response 1: SAWS is responsible to write the interface that brings the required data, provided by the contractor, into the SAWS-Infor Software and SAWS is responsible to write the interface that will export the required data to be imported into the contractor's software.

Question 2: Who is responsible for the interface to San Antonio Water Systems' existing utility billing software?

Response 2: See response to Question 1.

Question 3: How many users for software?

Response 3: 10.

Question 4: How many computers [will the] software be installed?

Response 4: The software is to be installed onto one server.

Question 5: Will SAWS consider customer references onboarded over 5 years ago with ongoing active change requests and upgrades?

Response 5: SAWS will conduct the Past Experience evaluation in accordance with the guidance as prescribed under the evaluation criteria titled, "PAST EXPERIENCE WITH SIMILAR PROJECTS."

Question 6: Will SAWS consider references from a deployment vendor actively using our solutions on including meter reading?

Response 6: See response to Question 5.

2. Update page 5 of 52 in its entirety in order to revise the language at Section I.C.2. to read:

"At SAWS option, this Contract may be renewed under the same terms and conditions for four (4) additional one (1) year periods. Renewals shall be in writing and signed by SAWS Director of Purchasing or his designee, without further action by the San Antonio Water System Board of Trustees, subject to and contingent upon appropriation of funding therefore."

- 3. SAWS shall also have the right to extend this contract under the same terms and conditions beyond the original term or any renewal thereof, on a month to month basis, not to exceed 6 months. Said month to month extensions shall be in writing, signed by SAWS Director of Purchasing or his designee, and shall not require Board approval, subject to and contingent upon appropriation of funding therefore.
