**1. Page IB-4, INSTRUCTIONS TO BIDDERS, 9., b. is amended to read as follows:**

Contractor agrees that, unless it is a sole proprietorship or a company with fewer than 10 full-time employees and the value of this Contract is less than \$100,000, it:

- a. does not boycott Israel and will not do so during the term of this Contract;
- b. does not boycott energy companies and will not do so during the term of this Contract;
- c. does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association and will not discriminate during the term of the Contract against a firearm entity or firearm trade association;

This provision is in compliance with Chapters §2271 and 2274 of the Texas Government Code. SAWS agrees to comply with the United States and Texas Constitutions in consideration of whether to enforce this provision.

**2. BID PROPOSAL.** Delete the Bid Proposal in its entirety and replace with the attached Bid Proposal footnoted Addendum No. 1. Respondents shall use the revised Bid Proposal when submitting a bid for this project.

**3. SUPPLEMENTAL CONDITIONS.** Remove Supplemental Condition to Article VIII – Contract Completion Time and replace with attached Supplemental Condition to Article VIII – Contract Completion Time in its entirety.
