 - (c) A completed and signed W-9 Request for Taxpayer Identification Number and Certification form.
 - (e) Conflict of Interest Questionnaire Form CIQ
 - (f) Proof of Insurability (Letter from Insurer or Sample Certificate of Insurance)
 - (g) Detailed baseline schedule

All other sections of the Instructions to Bidders shall remain the same.
