This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the Addendum number and issue date on the space provided in submitted copies of the bid proposal.

**RESPONSES TO QUESTIONS**

1. **Question** Police contractors have increased their hourly rate. Can "maximum bid of \$40.00 per HR" be removed?  
*Response: Yes, it will be removed to read only Police Officer. Please see #2, Changes to the Specifications.*
2. **Question** Can Line Items 56-60 be removed? (Line items in question do not pertain to this contract)  
*Response: No, these items are for asphalt replacements in an intersection.*
3. **Question** Since we are an SBE, are we still required to reach out to get other SBE quotes?  
*Response: If a contractor is SBE, more than likely you will meet the SMWB Goal; however, the Good Faith Effort Plan (GFEP) is a required document and we do require the form with your list of subcontractors/suppliers that will be utilized on this contract. A good faith outreach effort is still necessary.*
4. **Question** What is required to submit with our proposal in regards to GFEP?  
*Response: The GFEP form is required. On the GFEP, we require all subcontractors/suppliers listed will be utilized on this contract. All subcontractors/suppliers, regardless of SMWB status should be listed on the GFEP. If you do not reach the goal, see Section C of the GFEP.*
5. **Question** What is required to SMWB as a SBE if we are the successful bidder for job award.  
*Response: The successful bidder for this solicitation will be required to submit monthly payments to all subcontractors/suppliers utilized on this contract, in the SAWS SPUR System. If your firm or any subcontractors are not familiar with the process or entering payments/audits (and confirming – subcontractors/suppliers) the SMWB Department will be happy to provide training to anyone on how to use the SPUR System.*
6. **Question** What happens if we can't get quotes from any SBE, will the project still be awarded to the lowest bidder?  
*Response: This solicitation is an aspirational goal only and SMWB is only one component of the solicitation. The contracting department has additional criteria for awarding the contract in accordance with Instructions to Bidders document in solicitation packet.*

7. **Question** Do you have any examples to follow for templates that can be utilized for submittal purpose.  
*Response: There is not a template used for the submittal purpose, however please utilize the Bid Packet Checklist for all required documents..*
  
8. **Question** . What is an example of a work order for this contract? It helps with pricing bid items.  
*Response: This contract may require a hundred or more work orders in a year that differ in size and scope. No one particular work order can be considered to represent an “example” work order which may be issued. Location and conditions vary at for each work order and are also influenced by CoSA inspector requirements. Quantities provided in the Bid Proposal are estimated based on total historic contract use with a yearly basis and may or may not be used at the quantities listed. Refer to General Conditions 7.2 and Special Conditions 1.1, among other locations within the bid package for more explanation.*
  
9. **Question** Can SC-2.7 Performance Time / WO’s less that 900sq. ft. – seven (7) calendar days be changed to 14 calendar days? It takes just as much time to mobilize and transport material regardless of street cut square footage.  
*Response: This time has proven adequate in past contracts and no change will be made. SC-2.7 also states that the Contractor shall have the work force capacity to complete up to three (3) mil and overlay work orders per day during peak periods if such work orders are made available to the Contractor. Additionally, the Contractor shall provide enough resources to accomplish the workload assigned to the Contractor within the allotted time frame.*

**CHANGES TO THE SPECIFICATIONS**

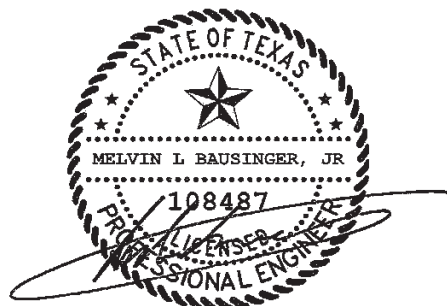
1. Due to updates in the General Wage Decisions for Building Construction Type, remove the wage decision document from the solicitation in entirety and replace with revised version (rev. 09/01/2023 for General Decision Number TX20230231). This version should be utilized by the awarded contractor for the project.
  
2. Remove the Bid Proposal in its entirety and replace with the attached revised Bid Proposal. Bidders shall use the revised bid proposal when submitting a bid for this project. Failure to use the revised version may result in the bid being found non-responsive.
  - a. Updated Bid Proposal line #26, “Police Officer (Maximum Bid of \$40.00 per HR)” to reflect “Police Officer (refer to SC-2.12)” and deleted \$40 max bid cap. Bidders are reminded police hours are invoiced without markup allowed per the Supplemental Conditions section 2.12.
  - b. Updated Bid Proposal line #42, “Hot Applied Thermoplastic Pavement Markings (Bicycle Rider Symbol)” and changed quantity from 252 to 2.

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

#### Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

#### Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all

rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

#### Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

#### WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- \* an existing published wage determination
- \* a survey underlying a wage determination
- \* a Wage and Hour Division letter setting forth a position on a wage determination matter
- \* a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator

The request should be accompanied by a full statement of the interested party's position and by any information (wage payment data, project description, area practice material, etc.) that the requestor considers relevant to the issue.

3.) If the decision of the Administrator is not favorable, an interested party may appeal directly to the Administrative Review Board (formerly the Wage Appeals Board). Write to:
