- 2. Question:** Can a bid item be added for tree protection?
Response: Per SAWS spec 101.4 tree protection is to be considered under Preparation of Right-of-Way.
- 3. Question:** Can we use 18" FRP pipe as an alternate for the 18" PVC pipe?
Response: See Changes to the Specifications #1. The option to bid on 18" FRP pipe has been added to the bid form.
- 4. Question:** Are the 60" FRP sewer manholes going to be tee-base or fully fiberglass?
Response: These manholes are to be tee-base manholes.

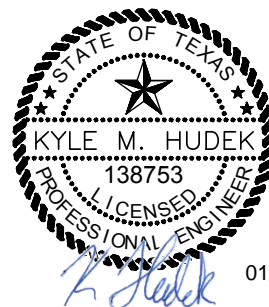
CHANGES TO THE SPECIFICATIONS
