#### To Bidder of Record:

This addendum, applicable to work referenced above, is an amendment to the bidding documents and as such will be a part of and included in the Contract Documents. ## **Bidding and Contract Requirements:**

1. Invitation to Bidders section, replace the first sentence of the last paragraph as follows:

"Sealed bids will be received by the Contract Administration Division, 2800 U.S. Highway 281 North, Customer Center Building, Suite 171, San Antonio, Texas 78212, until 10:00 a.m., Friday, June 1, 2012."

### **Clarifications:**

1. SAWS will facilitate a non-mandatory site visit for all interested bidders. The site visit is scheduled for <u>Wednesday</u>, <u>May 16</u>, <u>2012</u>. <u>All interested bidders shall meet promptly by 11 AM at SAWS Buckhorn Wellfield Construction Trailer located off County Road 123</u>, please see attachments for meeting location. This is the only date and time that will be available for a site visit by interested bidders. SAWS staff and Atkins staff will conduct this site visit and will leave promptly at 11 AM. It is anticipated the site visit will take between 2 to 3 hours. See attached Exhibit for Trailer location.

### **Questions:**

1. Prior to bid, Contractors are not allowed to visit and inspect the vast majority of the project right of way. They are not allowed to contact property owners along the project alignment. We are assuming the Owner will delete by addendum General Condition 5.6.1 from the Contract Documents. Is this correct?

Response General Condition 5.6.1 remains and is not deleted. .


