



**ADDENDUM NO. 1**

**To Respondent:**

This Addendum will be considered part of the Contract Documents and is issued to change, amplify, add to, delete from, or otherwise explain the Contract Documents dated September, 2011. Where provisions of this Addendum differ from those of the original Contract Documents, this Addendum will take precedence and govern. Respondents are hereby notified that they will incorporate this Addendum into their Proposals, and it will be construed that the Contractor's Proposal will reflect with full knowledge all items, changes, and modifications to the Contract Documents herein specified. Respondents will specifically acknowledge receipt of this Addendum.

**General Clarifications**

1. The mandatory Pre-Proposal Conference was held on October 12, 2011. Minutes from the meeting are attached and are considered part of this Addendum.
2. A list of SMWB-certified contractors who are capable of doing road work for the project is attached to this Addendum. For additional information specifically-related to subcontracting opportunities in the area, as well as information on the Small, Minority, and Woman-owned Business (SMWB) Program, please contact Marisol Robles via email at [marisol.robles@saws.org](mailto:marisol.robles@saws.org), or by telephone at (210) 233-3420. Information is also available on the SAWS website. Select "Business Center", then, "SMWB at SAWS".
3. SAIC Energy, Environment & Infrastructure team will provide construction staking of the temporary test injection well site, drill rig location and access road setting lathes and HUBS every 100 feet with PC and PT staking along one side of offsets.

**Contract Documents and Specifications**

1. Invitation to Competitive Sealed Proposals, remove Paragraph 4 and REPLACE with the following:

“A second, **non-mandatory** pre-proposal meeting will be held at **10:00 a.m. (local prevailing time) on October 26, 2011 in the Conference Room at SAWS ASR Wellfield Office, 4588 Hardy Road, Elmendorf, Texas 78112 in south Bexar County.** For questions regarding this solicitation, technical questions or additional information, please contact Diana Dwyer, Contract Administrator, in writing via email to: [ddwyer@saws.org](mailto:ddwyer@saws.org) or fax to (210) 233-5218 until **4:00 p.m. (local prevailing time) on October 27, 2011.** Answers to the questions will be posted to the web site by 4:00 p.m.



(local prevailing time) on **October 31, 2011** as a separate document or included as part of an addendum.”

2. Invitation to Competitive Sealed Proposals, remove the first sentence of Paragraph 5 and REPLACE with the following:

“Sealed Proposals will be received by the Contract Administration Division, 2800 U.S. Hwy 281 North, Customer Center Building, Suite 171, San Antonio, Texas 78212 until **10:00 a.m. (local prevailing time), November 4, 2011.**”

3. Remove the Good Faith Effort Plan (GFEP) and REPLACE in its entirety with the revised version attached to this Addendum.

4. Special Conditions, ADD the following:

“Non-mandatory Pre-Proposal - A non-mandatory pre-proposal meeting will be held at the location and time as indicated on the Invitation for Competitive Sealed Proposals.”

5. Section 01200, Measurement and Basis of Payment, Part I, Paragraph 1.10, Part 5, E.1. Remove the second paragraph and REPLACE with the following:

“The Contractor will remove all equipment, materials, etc. to return the well site to its pre-workover condition. This includes removal of fencing, pits, etc. constructed specifically for drilling and completing the well. It also includes disposal, off site, of all fluids, material and refuse on site that were a result of drilling and completion operations. The temporary access road shall not be removed.”

### **Questions & Answers**

1. Question: How does SAWS want the submittals to be packaged?

Answer: Per the Submittal Checklist it is anticipated there are three (3) parts that are comprised of the Proposal package: (1) Price Proposal shall be included in a separate envelope; (2) One (1) Original with the identified components; and (3) Seven (7) Copies of the submittal. The difference between the contents of the Original and Copy packages are outlined in the Submittal Checklist.

2. Question: When will the actual drilling occur?

Answer: SAWS does not anticipate giving a Notice-to-Proceed until January 2012.

3. Question: What is the loading of the service roads, culverts, cattle guards, concrete low water crossings?

Answer: The load rating for the roads, culverts, cattle guards, concrete low water crossings within the ASR property are rated for an HS20 axle load of 32,000 lbs. The Contractor shall



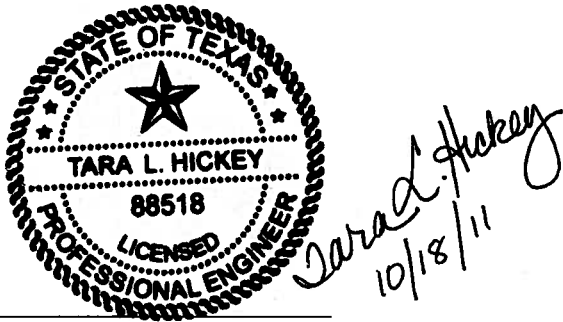
take preventative measures to avoid damaging any existing items and is responsible for replacing all items to existing or better conditions.

4. Question: Could the driller install a rig supply?

Answer: In order to obtain source water for the work, the Contractor will be allowed to drill a rig supply well at the pad for the injection well. Owner and Contractor to determine exact location of rig supply well. After completion of the test injection well, the rig supply well will be used as a Carrizo monitoring well. Owner will complete the permitting work with the Evergreen Underground Water Conservation District. Based on the geophysical logs of ASR Well No. 9, a well drilled to approximately 600 feet below land surface should provide adequate water for the injection well testing and drilling. This effort is subsidiary to all other work.

## **DEFINITIONS:**

**Prime Consultant/Contractor:** Any person, firm partnership, corporation, association or joint venture which has been awarded a San Antonio Water System contract.

**Subconsultants/contractor:** Any named person, firm partnership, corporation, association or joint venture identified as providing work, labor, services, supplies, equipment, materials or any combination of the foregoing under contract with a prime consultant/contractor on a San Antonio Water System contract.

**Small, Minority and Woman Business (SMWB):** All business structures Certified by the Small Business Administration, Texas State Comptroller's Office, or the South Central Texas Regional Certification Agency that are 51% owned, operated, and controlled by a Small Business Enterprise, a Minority Business Enterprise, or a Woman-owned Business Enterprise.

**Small Business Enterprise (SBE):** A business structure that is Certified by the Small Business Administration, Texas State Comptroller's Office or the South Central Texas Regional Certification Agency as being 51% owned, operated and controlled by someone who is legally residing in or a citizen of the United States, and the business structure meets the U.S. Small Business Administration's (SBA) size standard for a small business within the appropriate industry category

System, beginning with the first SAWS payment for services under the contract, and with every payment thereafter (for the duration of the contract).
