"Respondents will need to submit a request by June **25, 2021 at 2:00 PM (CDT) to receive access to the File Transfer Protocol (FTP) site via email to Janie.Powell@saws.org. Respondent's email requesting access to the FTP site shall provide the legal name of Respondent's company and the intended recipient's email address and phone number. No requests for FTP site access will be accepted after June **25**, 2021 at 2:00 PM (CDT)."**

3. **ELECTRONIC PROPOSAL OPENING INSTRUCTIONS.** The header and first two paragraphs are hereby modified to read as follows:

No requests for FTP site access will be accepted after **June **25**, 2021 by 2:00 pm (CDT)**. Once a Respondent is approved for access, an email with a hyperlink to the FTP site and a unique password for the Respondent will be provided to the Respondent's email recipient.

Once access is received, Respondents may upload the required documents per the revised Respondent's Proposal Checklist any time before **June **28**, 2021 at 2:00 PM (CDT)**. **Please ensure to allow sufficient time should Respondents experience technical difficulties in uploading the required documents. No changes to the proposal price can be made once the proposal has been submitted.**

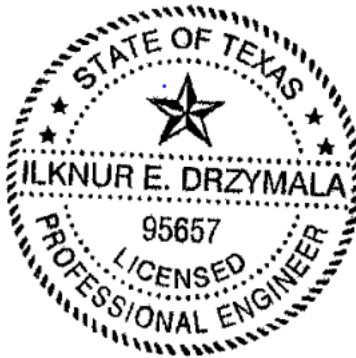
RESPONSES TO QUESTIONS

1. **Question:** Contract drawing E-512 indicates sites 323, 24, 25, 28, & 30 communicate via fiber. Specification 13320- Fiber Optic Data Network provides details for the provision of new fiber cable. However, the contract drawings for these sites do not address any fiber details of new or existing fiber.

Response: The Contractor's work ends at the patch panel as shown in the contract documents. These lift stations will be transferred to JBSA after the completion of the project, and all fiber and final connections will be done by JBSA after the transfer.
