RESPONSES TO QUESTIONS

1. **How much 3D will be required for this project? And if 3D is required to what extent?**

See Response to Q#24 of Addendum 1.

2. **Will there be any structural engineering involved in this project?**

See Response to Q#20 of Addendum 1.

3. **Does this project require tunneling?**

The 30% PER identifies four (4) trenchless segments with recommended methods that include open-shield pipe jacking, microtunneling, and horizontal auger boring.

4. **I had a question regarding the Respondent Checklist form and the RFQ Section C. Response Format (page 23 of 115). The Submittal Checklist from Addendum 1 has the GFEP listed as Exhibit A (versus B), no Exhibit B, D or E, and COI as Exhibit C. Does this need to be revised? I know questions are answered in Addendum 1, but they don't seem to be reflected on the new Submittal Checklist. I may be interpreting wrong. Please advise.**

See #1 of Changes to the RFQ in this Addendum re: Exhibit A. Exhibit C is referenced in the revised Respondent Checklist. There are no additional forms as Exhibits D and E are to be acknowledged on the Respondent Questionnaire.

5. **Can SAWS provide the required project completion date required by the EPA per the CD and any extensions that apply?**

The Consent Decree deadline for this project is 7/22/2027.

6. **Regarding Section VII. Other Requirements, Item C. Disclosure of Interested Parties (Form 1295): would you please clarify whether a signed Form 1295 is required to be submitted with the response to this RFQ?**

A 1295 is not required with the response to this RFQ. Once a consultant is selected and negotiations completed, SAWS will require a Form 1295 from the selected firm with their signed Professional Services Agreement.

7. **Since many of the SAWS projects in the last couple of years were small diameter or condition related, would SAWS consider extending the 5 year time limit on past project experience to 8 years?**

For this RFQ, the time limit on past projects is 5 years.

8. **If we are using task order contract as one of our five projects under past performance, what is the best way to show the information on similar project and past performance form, is it ok to start and completion date for contract, and description of all applicable task orders?**

If using a task order contract, list the most relevant work orders together with required information of the work performed for each. Consultants to put the best information forward to demonstrate their qualifications. SAWS retains sole discretion regarding the evaluation of similar projects and past performance requirements

9. **RFQ allows two projects from subconsultants, can these projects be where subconsultant performed as a subconsultant and not as a prime?**

Yes, the two projects from subconsultants may be where subconsultant performed as a subconsultant. Consultants to put the best information forward to demonstrate their qualifications. SAWS retains sole discretion regarding the evaluation of similar projects and past performance requirements

10. **Are there any stipulations on a minimum percentage that the prime firm has to self-perform?**

No, there are no stipulations on a minimum percentage that the prime firm has to self-perform.

11. **Is a Table of Contents allowed? If so, does it count toward the page limit?**

A Table of Contents is allowed and will not count toward the page limit. See section II.C. Evaluation Criteria Summary, page 15 of the RFQ for page limits.

12. **For the Similar Projects Form, is it acceptable to recreate the form if we include the same information fields?**

Yes, this is acceptable as long as the number of pages are not exceeded.
