Part 1 Equipment

1.01 Description

1.01.1 Data Collection

Flow meters shall collect data at five (5) minute intervals and transmit data at four (4) hour intervals. Flow meters shall collect and transmit data at five (5) minute intervals during an alarm condition and will return to transmitting data every four (4) hours when the conditions return to normal status.

Data shall be transmitted, either through telemetry or some other accepted means. To prevent loss of data, the device shall store all readings for a period of at least thirty (30) days.
