Questions submitted for Bid No. 19-19000, Sanitary Sewer Public Lateral Inspection Services:

**Question 1:** *“Could SAWS clarify whether the lateral videos should be appended to the main videos or submitted as separate files?”*

**Answer 1:** Each lateral should have a separate video file identified by its lateral asset identification (UNITID) number.

**Question 2:** *“Could SAWS clarify Pg 13, item 8, where it states this contract may be awarded to the lowest responsible bidder or the lowest responsible bidder per item.”*

**Answer 2:** The contract will be awarded to the overall lowest responsible bidder.
