***** This **Addendum 1** is issued to make the following changes on Bid 19-19018.

On Page 15 of 24, Item 8 should read as follows:

CHANGE FROM:

8. The unit shall be equipped with a high visibility design, triple (3) stage mast rated at a minimum 3,500 lb. At 24" load center and a lift height of not less than 192". The overall collapsed height of 131". The mast shall have a free lift of 76" and a carriage tilt of a minimum 3-degrees forward and 4-degrees back. The mast shall be equipped with a heavy-duty load backrest and hydraulically operated fork positioning, side-shift integral-hook carriage with mesh screen mast guard. Carriage shall have a minimum reach of 22". The forks shall be a minimum of 1.4" thick x 4" wide x 42" long, pallet type forks.

CHANGE TO:

8. The unit shall be equipped with a high visibility design, triple (3) stage mast rated at a minimum 3,500 lb. At 24" load center and a minimum lift height of not less than 210". The overall collapsed height of 95". The mast shall have a minimum free lift of 39" and a carriage tilt of a minimum 3-degrees forward and 4-degrees back. The mast shall be equipped with a heavy-duty load backrest and hydraulically operated fork positioning, side-shift integral-hook carriage with mesh screen mast guard. Carriage shall have a minimum reach of 22". The forks shall be a minimum of 1.4" thick x 4" wide x 42" long, pallet type forks.
