## **QUESTIONS AND RESPONSES**

1. Is the request for 3 x Hard Drives total approximately 16TB to 20TB or is each drive to be around that capacity? Would you accept 14TB Hard Drives?

Response: The Salient part numbers being requested are designed to have either 16TB or 20TB of total storage. No deviation from the Salient part numbers will be accepted as stated on page 16 of the Invitation for Bid document.

2. We would configure with Server 2019, since 2016 is End of Life (EOL). Would this be acceptable?

Response: Server 2016 is not end of life. No deviations from the Salient part numbers will be accepted as stated on page 16 of the Invitation for Bid document.

3. We are not able to provide a BOSS Controller Card. It appears this product is also EOL. We would use the onboard Raid for the Raid 5 set-up. Would this be acceptable?

Response: We are requesting Salient video servers, they come with the BOSS controller card. No deviations from the part numbers will be accepted as stated on page 16 of the Invitation for Bid document.

## 4. There is no mention of chassis height. Is 3U high acceptable? This option will provide sufficient drive bays. We could also offer a 2U high solution. Which would be preferred?

Response: We are requesting Salient video servers, the Salient part numbers have a defined chassis height. No deviations from the part numbers will be accepted as stated on page 16 of the Invitation for Bid document.

#### 5. It is quantity (6) and (8) of each configuration that needs to be quoted?

Response: No. Items and quantities to be quoted can be found on the Price Schedule on page 18 of the Invitation for Bid document. Technical requirements can be found on page 15 of the same document.

### 6. Do you anticipate extending the bid due date?
