Please make the following changes to subject bid form mailed to you April 19, 2012.

On Page 15 of 24 under **Minimum Specifications**, Item No. 4 should read as follows:

4. Manufacturer's anti-lock full air brake system, S-cam style for GVWR specified with a minimum 16 CFM minimum air compressor and in-line air-dryer, Bendix, Anti-Lock 4-channel brake system or equal. Spring-loaded parking brakes shall be furnished on the rear axle. All brakes shall include automatic slack adjuster, and dust shields. Parking brake shall automatically activate when main air system pressure drops below DOT regulations.

On Page 16 of 24 under **Minimum Specifications**, paragraph should read as follows:

### **Minimum Specifications**

The intent of this specification is to describe the minimum requirements for a truck type, High Pressure Sewer Cleaner designed to use high-velocity water jets to remove obstructions, soluble grease, sand, and other materials from the sanitary sewers. The unit, including all necessary equipment shall be furnished complete and ready for use. All parts not specifically mentioned, which are required for a complete unit shall be included and conform in design, strength, quality of material and workmanship to the highest standards of engineering practices. The high-pressure sewer cleaner shall be mounted on a new 37,000 GVWR conventional cab/chassis. The cab to axle and wheelbase of the vehicle shall be determined by the equipment manufacturer's recommendation for the installation of the mounted high-pressure sewer cleaner body. The unit shall include all manufacturer's standard equipment and safety components unless otherwise specified or replaced herein. Prototypes or unapproved units are not acceptable
