Please make the following changes to subject bid form mailed to you May 11, 2012.

On Page 14 of 29 under **ITEM A – Excavator track crawler mounted, hing boom, minimum 47,000 lbs. operating weight with attachments, MINIMUM SPECIFICATIONS**, Item No. 1 should read as follows:

1. The engine shall be a Tier IV compliant model four-cycle, 4-cylinder (**Minimum**), liquid cooled, diesel engine. The diesel engine shall have a SAE net rating of 157 HP (**Minimum**), at 2,100 RPM (**Maximum**).

On Page 14 of 29 under **ITEM B – Four-Wheel Drive, Rubber tire articulated loader (4-cubic yard), MINIMUM SPECIFICATIONS**, Item No. 1 should read as follows:

1. The engine shall be Tier IV compliant model four-cycle, 6-cylinder, liquid cooled, turbo charged diesel engine. The turbo charged 6-cylinder engine shall have a displacement of 411 cubic inches 6.7 liter (**Minimum**), and an SAE net rating of 195 HP (**Minimum**), at 2200 RPM (**Maximum**).
