On Page 21 of 25, Item No. 31a. should read as follows:

- 31a. 5,000# Lifting capacity at 6' from centerline of the crane
- 3,125# Lifting capacity at 8' from centerline of the crane
- 2,500# Lifting capacity at 10' from centerline of the crane
- 2,080# Lifting capacity at 12' from centerline of the crane
- 1,785 #Lifting capacity at 14' from centerline of the crane
- 1,560# Lifting capacity at 16' from centerline of the crane.
