Question 1: Is the Intent to awards to only one vendor?

Question 2: Material Description on Price Schedule.

Question 4: What is the contractor does not carry a particular product listed on the “Price Sheet”?

Answer: *All items must be bid on – If a contractor does not normally carry a specific item on the price sheet he/she is allowed to sub-contract. Again, all items must include a quoted price per unit.*
