Questions & Answers:

Question 1: Will these licenses be going into an HP environment/going onto HP systems? Or Lenovo or Dell?

Answer: These will be used on a Cisco UCS platform. The only thing on HP is the vCenter server.

Question 2: Is your HP server a new addition to the environment and is added within 30 days period?

Answer: All SAWS' ESX servers and host are off the HP for over 1 year. The only thing we have for VMware is vCenter.
