The original contract documents and any prior addenda remain in full force except as modified by the following, which shall take precedence over any contrary provisions in prior documents.

**Questions and Answers:**

The following written questions were received by SAWS prior to the April 21, 2015 deadline. Responses to the questions are provided as follows:

Question 1: *“I would like to see if there are any plans for the following projects:*

- 1) 2015 Annual Sanitary Sewer Main Point Repair, Manhole Adjustments and Laterals Construction Contract – Package 1*
- 2) 2015 Annual Sanitary Sewer Main Point Repair, Manhole Adjustments and Laterals Construction Contract – Package 2”*

Answer: This is a work order contract. All work that will be issued under this contract is unspecified at the time of bidding. Therefore, there are no plans. There are, however, drawings of details referenced in the bid documents that are found in the standard specifications. SAWS Standard Drawing No. DD-852-01 is an example. SAWS standard specifications are posted on the SAWS internet web site at [http://www.saws.org/business\\_center/specs/constspecs/](http://www.saws.org/business_center/specs/constspecs/).

Question 2: *“I have downloaded the Specifications, but could not find links to download the Plans to the following Invitations for Bid:*

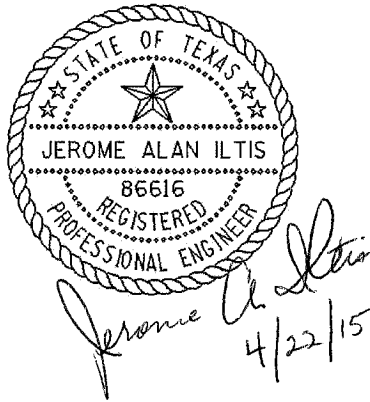
